I understand **Enthusiast Membership** of the QMSC is **FREE** and that no membership benefits are accrued except that I become part of an organisation that advocates on behalf of recreational motorised sports activities and other benefits as advised and/or decided by the QMSC from time to time.

I understand **Supporter Membership** of the QMSC is based on payment of the annual fee of **\$22** including GST. Any benefits that accrue to the membership are dependent on being a current financial member of QMSC. Membership benefits include access to optional extras such as SIV Registration and Personal Insurance.

I understand by becoming a Supporter of the QMSC I am eligible to apply for **Concessional Special Interest Vehicle (SIV) Registration**. To complete this process I will complete and return the SIV Application for Dating Certificate form found on www.qmsc.org.au to QMSC with all required paperwork identified on the SIV Application form and pay the **\$22** fee.

I understand by becoming a Supporter of the QMSC I am eligible to apply for **Personal Accident Insurance**. This covers the Supporter travelling to and from QMSC authorised events and meetings. The policy arranged with JLT is placed with QBE and provides cover for capital benefits up to \$50,000 for death, loss or limbs or injury thereof to a QMSC Supporter aged from 12 to 80 years of age. Weekly benefits of normal weekly wages up to \$500 per week for up to 104 weeks are also provided. For any QMSC Supporter aged between 81 to 90 years of age the capital benefit is reduced to \$10,000 and weekly benefits of normal weekly wages reduced to \$100 per week for a period of 26 weeks. The fee is **\$33**.
